### MINUTES OF THE MEETING SOUTH ROCK ISLAND TOWNSHIP BOARD MONTHLY AUDIT

### STATE OF ILLINOIS County of Rock Island Town of South Rock Island

The South Rock Island Township Board met at the Office of the Town Clerk, located at 1019 27th Avenue, Rock Island, Illinois, on May 23, 2016, at 5:00 pm.

#### Approval of the May Agenda and Minutes of the April meeting:

Alongi moved, and Shuda seconded, to approve the Agenda (Record). Voice vote. Motion carried.

Parr moved, and Skafidas seconded, to approve the April 25, 2016, Township Board minutes. Voice vote. Motion carried.

#### Reports:

Grace Diaz Shirk provided the Supervisor's Report (*Record*). The Supervisor announced that due to changes at Timmer, the accounting will be done by Hoffman & Tranel. Hoffman & Tranel employees formerly with Timmer know the Township accounts and will continue the service at the same price. There was consensus from the Township Board to support the Supervisor on this change.

Supervisor Shirk attended the 11/31 business meeting and updated the Township Board. There was discussion on projects throughout the city including Walmart, CVS, and the 11th Street corridor.

The Supervisor announced that the Try-Play partnership would be continuing with new leaders at the Parks & Recreation Department and the Dr King Center, John Gripp and Jerry Jones, respectively.

Supervisor Shirk informed the Township Board that she conducted employee evaluations and heard feedback from the staff on building improvements. The Township Board supported the Supervisor's plan to move forward with building improvement projects including resealing windows, replacing carpet and flooring, and resealing and restriping the parking lot asphalt. All projects are budgeted and bids have come in below budgeted amounts.

The Township staff is working on ideas to celebrate Township Day in September. The Supervisor stated that some of the ideas include a cookout, meet and greet, open house, press release, and presentations to students about Townships, among others.

Supervisor Shirk stated that the NAACP Community Day and Resource Fair is scheduled for August 27, 2016, from 12 to 4 pm.

Nick Camlin verbally provided the Town Clerk's Report. Skafidas asked about an inquiry to emails between Township Officials. Town Clerk Camlin explained that if the communications are done on private personal email accounts that they cannot be tracked by the Township, and cautioned that anything done using private resources pertaining to Township business should be considered open to the public.

Susan Carpentier did not provide an Assessor's Report.

The Supervisor provided the April 2016 General/Emergency Assistance Report (Record).

The April 2016 Senior Citizen/Disabled Report was printed on the Agenda.

#### Treasurer's Report and Town Fund Bills:

Supervisor Shirk provided the Treasurer's Report (Record). The Township Board audited the bills and

claims (*Record*). Shuda moved, and Skafidas seconded, to authorize payment of the Town Fund and Relief Fund bills and transfers in the amount of \$26,764.63. Roll call vote. Five votes in favor: Parr, Shuda, Skafidas, Alongi, and Shirk. No votes in opposition. Motion carried.

#### **Unfinished Business:**

After discussion at the last Township Board meeting, Supervisor Shirk reached out to the local Special Olympics chapter to inquire about how many Township residents participate in the athletic events. An email response indicated that there were at least 43 athletes from South Rock Island Township. Alongi moved, and Supervisor Shirk seconded, to donate \$250 to the Special Olympics for their local athletic events. Roll call vote. Five votes in favor: Shuda, Skafidas, Alongi, Parr, and Shirk. No votes in opposition. Motion carried.

#### **New Business:**

Parr moved, and Shuda seconded, to approve the Public Participation Policy for Township Board meetings (*Record*). Voice vote. Motion carried.

No action was taken on a Birdies for Charity request from CADS (Center for Alcohol and Drug Services).

Skafidas stated that he was opposed to the donation for Newspapers in Education because the newspaper is always advocating eliminating Townships and because he does not feel taxpayer money should subsidize a dying industry. Parr agreed with Skafidas. The Supervisor stated that it is not about the company getting a donation, it is about the children having access to a newspaper. Alongi agreed with the Supervisor and pointed out that we get publicity for sponsoring the program. Supervisor Shirk moved, and Alongi seconded, to donate \$300 to the Argus/Dispatch Newspapers in Education program to sponsor a set of newspapers on the condition that it supports Rock Island High School. Roll call vote. Three votes in favor: Alongi, Shuda, and Shirk. Two votes in opposition: Skafidas and Parr. Motion carried.

Parr moved, and Skafidas seconded, to donate \$50 each to the Rock Island Police and Fire honorees, and four \$25 gift cards for gas or Township restaurants, for a total of \$200 for the annual Civics Awards. Five votes in favor: Skafidas, Shuda, Parr, Alongi, and Shirk. No votes in opposition. Motion carried.

Alongi moved, and Shuda seconded, to donate \$200 to Youth Hope for four local children to attend summer day programs at \$50 each. Roll call vote. Five votes in favor: Skafidas, Shuda, Parr, Alongi, and Shirk. No votes in opposition. Motion carried.

Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on these financial statements.

The financial statements are prepared in accordance with the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

The accompanying annual appropriations listing of South Rock Island Township for the year ending March 31, 2017 has not been compiled or examined by us, and accordingly, we do not express an opinion or any other form of assurance on it.

The Township has elected to comply with the provisions of GASB Statement No. 34, *Basis Financial Statements – and Management's Discussion and Analysis – for State and Local Governments*, as amended and interpreted. This requires that the Township reflect its fixed assets net of depreciation. The balance reflected is from their March 31, 2016 Illinois Annual Financial Report.

Management has elected to omit substantially all of the disclosures ordinarily included in financial statements prepared in accordance with the cash basis of accounting. If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the government's assets, liabilities, fund balances, revenues, and expenditures. Accordingly, the financial statements are not designed for those who are not informed about such matters.

### Public Participation Policy for South Rock Island Township Board Meetings 5/23/2016

The Board of the South Rock Island Township recognizes the value of public comment on township issues and the importance of allowing members of the public to express themselves on matters of community interest.

In order to permit the fair and orderly expression of such comment, the Board shall provide a period for public comment at every regularly scheduled public meeting of the Board.

Public participation shall be extended to residents of this township, persons having a legitimate interest in the actions of this Board, persons representing groups in the community or school district, representatives of firms eligible to bid on materials or services solicited by the Board, and employees. Public participation shall be governed by the following rules:

- A participant must be recognized by the presiding officer and must preface comments by an announcement of his/her name, place of residence, and group affiliation, if appropriate.
- 2. The subject shall be limited to items that deal with business that affects the township.
- 3. There shall be a limit of 3 minutes for comments per person.
- 4. The Supervisor may stop a person from further comments if those comments are irrelevant, repetitious, or disruptive.
- 5. All questions asked by the board shall add one minute to the person for an answer per board question.
