MINUTES OF THE MEETING SOUTH ROCK ISLAND TOWNSHIP BOARD MONTHLY AUDIT

The South Rock Island Township Board met at the Office of the Town Clerk, located at 1019 27th Avenue, Rock Island, Illinois, on November 21, 2016, at 5:00 pm.

Approval of the November Agenda, Minutes of the regular October and special November meetings:

Skafidas moved, and Alongi seconded, to approve the Agenda (Record). Voice vote. Motion carried.

Parr moved, and Skafidas seconded, to approve the October 24, 2016, Township Board minutes. Voice vote. Motion carried.

Skafidas moved, and Parr seconded, to approve the November 14, 2016, special Township Board meeting minutes. Voice vote. Motion carried.

Reports:

Grace Diaz Shirk provided the Supervisor's Report (*Record*). Township staff volunteered their time on October 22, 2016, to support the efforts of the CAUSE Drug Take Back Day, where 559 pounds of prescription drugs were collected.

The Township hosted a blood drive on October 26, 2016.

Supervisor Shirk reported that the Township participated in Fright Night on October 27, 2016, and handed out approximately 1,500 to 2,000 pieces of candy and gifts that were left over from Township Day. Additionally, the Township hosted Fall Fun for students.

The Supervisor stated that property value estimates for the RICAP building at approximately \$75,000 (Record). The Township Board will discuss the options for the property in the future.

The Little League Scholarship program provided aid in the amount of \$210, out of the \$1,500 approved, for Township youth in need. Last year, \$645 was provided to aid participants in need.

Supervisor Shirk reported that employee health insurance premiums are being reduced by 18%, or \$86.35 per employee per month, effective December 1, 2016. The Supervisor credits the young age of the staff, use of the clinic, and fewer visits to doctors.

The senior Christmas breakfast will be held at the Township Hall on December 12, 2016, from 9:30 am to 11:30 am, and the client Christmas luncheon will be on December 15, 2016 from 12 to 2 pm.

The Supervisor reminded the Township Board that the deadline for Township Resident Award nominations is December 31, 2016.

Supervisor Shirk also provided the Township Board copies of the 2017 holiday schedule and the senior food relief program rules for 2017 (*Record*).

Nick Camlin provided the Town Clerk's Report (*Record*). The Town Clerk reported that the Township Caucuses are set for December 6, 2016, and the parties have responded with their respective locations (*Record*). The Town Clerk also raised a concern about the Township email account and the archiving of emails since the online storage was running low.

Nichole Finnie provided the Assessor's Report (*Record*). Assessor Finnie provided clarification on updating photographs of properties.

MINUTES OF THE MEETING

The Supervisor provided the October 2016 General/Emergency Assistance Report (*Record*). The October 2016 Senior Citizen/Disabled Report was printed on the Agenda.

<u>Treasurer's Report and Town Fund Bills</u>:

Supervisor Shirk provided the Treasurer's Report (*Record*). The Township Board audited the bills and claims (*Record*). Parr moved, and Alongi seconded, to authorize payment of the Town Fund and Relief Fund bills and transfers in the amount of \$40,004.11. Roll call vote. Four votes in favor: Parr, Skafidas, Alongi, and Shirk. No votes in opposition. Motion carried.

Unfinished Business:

An update on the Thanksgiving certificates was provided on the Agenda.

New Business:

Supervisor Shirk presented the draft tax levy ordinance 2016-5 (*Record*). She stated that the Township's FY 2017 property tax levy would not increase (0% raise) for the third year in a row. Parr moved, and Skafidas seconded, to place on display the FY 2017 Property Tax Ordinance 2016-5. Final adoption will be at the December meeting. Voice vote. Motion carried.

Parr moved, and Alongi seconded, to approve the resolution to schedule of Township Board meetings for 2017 (*Record*). Voice vote. Motion carried.

Parr moved, and Skafidas seconded, to approve the 2017 monthly audit schedule of meetings (*Record*). Voice vote. Motion carried.

Alongi moved, and Skafidas seconded, to approve the Social Media Policy (*Record*). Voice vote. Motion carried.

No action was taken on a request for donation from River Bend Foodbank.

Skafidas moved, and Alongi seconded, to donate \$200 to ARC of the Quad Cities for local developmentally disabled residents. Supervisor Shirk will ask how the funds are being used. Roll call vote. Four votes in favor: Skafidas, Alongi, Parr, and Shirk. No votes in opposition. Motion carried.

No action was taken on a request for donation from Alleman High School for the Heritage Ball.

Public Comments:

Skafidas commended Supervisor Shirk and Town Clerk Camlin for their jobs and taking on all that they do. Skafidas also stated that the local food pantries are very helpful to the community.

Parr reported that the November RICTA meeting provided good information about the Illinois Treasurer's Office.

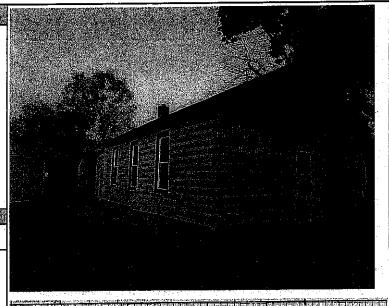

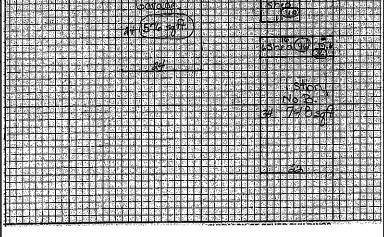

This requires that the Township reflect its fixed assets net of depreciation. The balance reflected is from their March 31, 2016 Illinois Annual Financial Report.

Management has elected to omit substantially all of the disclosures ordinarily included in financial statements prepared in accordance with the cash basis of accounting. If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the government's assets, liabilities, fund balances, revenues, and expenditures. Accordingly, the financial statements are not designed for those who are not informed about such matters.

Social Media Policy

1. Purpose of Policy

The purpose of the South Rock Island's social media pages is to disseminate information to our residents, taxpayers, and the general public about the activities and events that are held throughout the year.

Users are encouraged to submit comments, questions and concerns, but please note that Township social media sites may serve as moderated online discussions and not public forums.

2. Social Media Tools

Social Media platforms allow users to share and upload media content such as photographs, videos and comments to the internet quickly and easily.

Social networks are one of the fastest growing areas in modern technology and is an effective way to encourage multi-way communication with stakeholders.

Social networking sites such as Facebook, Twitter, YouTube, LinkedIn

3. Moderation

Comments containing any of the following content shall not be permitted and can be subjected to removal and/or restriction:

- Comments that contain solicitation, or advertising for any business/company or products for sale
- Profane, obscene, violent, sexual, or pornographic content and/or language
- Comments not related to the original topic, including random or unintellectual comments
- Content that promotes, fosters, or perpetuates discrimination on the basis of race, sex, color, age, religion, gender, sexual orientation, or national origin
- Defamatory statements or personal attacks
- Treats to any person or organization
- Conduct in violation of any federal, state, or local laws
- Encouragement of illegal activity
- Information that may tend to compromise the safety or security of the public or public systems
- Spam or links to other sites
- Content in support of or opposition to political campaigns or ballot measures
- Information about a user that is private or personal
- Content that violates a legal ownership interest, such as copyright or trademark

4. Standards

The Township will uphold certain standards when dealing with the social media platforms. Those are outlines below:

- This policy governs all social media use by or on behalf of the Township.

 The Township shall have a single, official presence on each social media site approved for use.

 All Township presence and activity on social media are an integral part of the Township's information networks, and must comply with all rules and policies governing the Township's computers and electronic media, as detailed in the Personnel Policy.

 All Township users of social media are responsible for complying with applicable federal, state, and county laws, regulations, and policies. This includes adherence to established laws and policies regarding copyright, records retention, Freedom of Information Act (FOIA), First Amendment, privacy laws, sunshine laws, and information security policies (if applicable) established by the Township.

- Wherever possible, links to more information should direct users back to the Township's official website.

- Employees representing Township government on social media outlets must identify themselves by name, and when relevant, by role at the Township. All Township policies are applicable to interactions on social media sites when acting in an official capacity and representing the Township.

- The designated Township Administrator(s) shall monitor content on all social media sites to ensure adherence to the Social Media Policy for appropriate use, message, and branding consistent with Township goals.

- No "friending," "liking" or other special relationship between a Township elected official or employee and a third person is permitted.

- Social media sites are not to be used for making any official communications to the Township, for example, reporting crimes or misconduct, reporting dangerous conditions, giving notice required by any statute, ordinance or regulation (e.g. notice of claim). Prominent notice of this paragraph shall be displayed on every Township social media site, along with the appropriate contact information for submitting such a communication.

 The Township Administrator(s) or duly designated Webmaster shall have the authority to remove any Prohibited Content from any Township social media site at any time, subject to archiving and retention requirements.

5. Applicability

This policy shall apply to all Township elected officials and employees permitted by the Township to post on Township social media sites.
