## MINUTES OF THE MEETING SOUTH ROCK ISLAND TOWNSHIP BOARD MONTHLY AUDIT

The South Rock Island Township Board met at the Office of the Town Clerk, located at 1019 27th Avenue, Rock Island, Illinois, on December 19, 2016, at 5:00 pm.

#### Approval of the December Agenda and Minutes of the November meeting:

Skafidas moved, and Alongi seconded, to approve the Agenda (*Record*). Voice vote. Motion carried.

Shuda moved, and Skafidas seconded, to approve the November 21, 2016, Township Board minutes. Voice vote. Motion carried.

#### Reports:

Grace Diaz Shirk provided the Supervisor's Report (*Record*). The Supervisor thanked Bill and Edna Sowards for volunteering their time as Santa & Mrs Claus for the senior and client Christmas parties.

The deadline for the 2017 Township Resident Award nominations is December 31, 2016.

The Supervisor informed that Township Board that the partnership with Try Play would continue with the spring Easter egg hunt.

Supervisor Shirk announced that the RICAP lease will continue for two more months while they seek approval for disbanding, as long as they continue to cover utilities.

A pending water bill for \$557.48 is being investigated because of its unusually high amount.

The Supervisor stated that the media published the Township Hall warming center while the temperatures were extremely low.

Supervisor Shirk is seeking bids for Township Hall phones and security cameras.

The cost of snow removal from Love Electric is \$50 per visit.

Supervisor Shirk informed the Township Board that she will be on vacation in January, and the Trustees will need to select a Chairman for the January 30, 2017 Township Board meeting.

The Supervisor informed the Township Board that the Township Hall offices will be reorganized after the holidays. The Township and General Assistance offices will be in the front of the building, and the Assessor's office will be moved to the back of the building. Supervisor Shirk explained that the move is being done because of the volume of Township programs servicing more people needs more space, and also because residents for Township services came in through the front Assessor's office and were told to walk around the building to the rear Township offices, which is unacceptable. Supervisor Shirk stated that it makes more sense and is efficient. People line up to use the Township computers, and it is rare that there is a line in the Assessor's office, except for the leaf bags.

Alongi asked about parking and the Supervisor replied that staff will still park in the back and the front would be for clients only.

Parr asked about costs and efficiencies, and the Supervisor replied that the cost would be low,

easy to do, and it would improve efficiency and morale in the community as people get their services.

Skafidas said it made sense to have the General Assistance and Township services in the front.

Assessor Finnie asked why this was not discussed between her and the Supervisor to work something out first. Supervisor Shirk replied that it is because she is bringing to her Township Board first.

The Supervisor stated that the Assessor's office would fit in the rear and that there is lots of storage in the front now that is already used due to Township programs. The Supervisor assured the Assessor that they could get everything they needed to do their jobs.

Supervisor Shirk announced that the University of Illinois Extension would be hosting classes at the Township Hall for seniors in January, including health, nutrition, and cooking. Possible youth cooking classes could be in the summer and the Extension provides all the equipment.

Nick Camlin provided the Town Clerk's Report (*Record*). The Town Clerk had the Township Officials verify their addresses for the annual Statement of Economic Disclosure.

Town Clerk Camlin also provided clarification on the lottery for party placement on the April 4, 2017, ballot as well as rules governing such lotteries.

The Township Board agreed to proceed now with the lottery, rather than wait until further down on the agenda. Town Clerk Camlin asked representatives from each party to examine the bag and tokens for the lottery. Alphabetically, the Democratic Party would be represented by token number one, and the Republican Party would be represented by token number two. The Town Clerk drew the token number one first, indicating the Democratic Party would get the top ballot placement, and token number two was drawn last (Record).

The Town Clerk stated that the address verifications, ballot certification, and property tax levy ordinance would be filed with the County Clerk on December 20, 2016.

Nichole Finnie provided the Assessor's Report (Record).

The Supervisor provided the November 2016 General/Emergency Assistance Report (Record).

The November 2016 Senior Citizen/Disabled Report was printed on the Agenda.

#### Treasurer's Report and Town Fund Bills:

Supervisor Shirk provided the Treasurer's Report (*Record*). The Township Board audited the bills and claims (*Record*). Shuda moved, and Skafidas seconded, to authorize payment of the Town Fund and Relief Fund bills and transfers in the amount of \$54,914.66. Roll call vote. Five votes in favor: Parr, Shuda, Skafidas, Alongi, and Shirk. No votes in opposition. Motion carried.

#### **Unfinished Business:**

None.

#### **New Business:**

Supervisor Shirk presented the property tax levy ordinance 2016-5 for final approval (*Record*). She stated that the Township's FY 2017 property tax levy would not increase (0% raise) for the third year in a row and that we have even more programs than ever before. Parr moved, and Skafidas seconded, to adopt the FY 2017 Property Tax Ordinance 2016-5. Roll call vote. Five votes in favor: Shuda, Skafidas, Alongi, Parr, and Shirk. No votes in opposition. Motion carried, ordinance adopted.

No action was taken on donation requests from the Rock Island-Milan Education Foundation and Youth Hope.

#### **Public Comments:**

Stacie Young asked about the wall in the space and whether it could be removed to be more personable, and Supervisor Shirk replied that that could be done.

Wendy MacDonald stated that the leaf bags did not put them behind in their work in the

Assessor's office, but that the goal was to get everything updated. Not because of lapsing but because it is a goal the new staff set, to have the most up-to-date records. She stated that they were told as new employees not to allow clients there there were no cameras and that is why sometimes clients were asked to walk around the building.

We did not audit or review the financial statements nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on these financial statements.

The financial statements are prepared in accordance with the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

The accompanying annual appropriations listing of South Rock Island Township for the year ending March 31, 2017 has not been compiled or examined by us, and accordingly, we do not express an opinion or any other form of assurance on it.

The Township has elected to comply with the provisions of GASB Statement No. 34, Basis Financial Statements – and Management's Discussion and Analysis – for State and Local Governments, as amended and interpreted. This requires that the Township reflect its fixed assets net of depreciation. The balance reflected is from their March 31, 2016 Illinois Annual Financial Report.

Management has elected to omit substantially all of the disclosures ordinarily included in financial statements prepared in accordance with the cash basis of accounting. If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the government's assets, liabilities, fund balances, revenues, and expenditures. Accordingly, the financial statements are not designed for those who are not informed about such matters.
