Call to Order/Roll Call - The June 5, 2026 “Special” South Rock Island Township Board meeting was called to order at 9:00 am by acting Supervisor Bill Sowards.

Remote Electronic Attendance (if necessary) – A motion was made by **Elsberg** and seconded by **Hebbeln** to allow the remote attendance of Supervisor Shirk due to a family illness emergency, as permitted under the Illinois Open Meetings Act. Roll call vote. 3-Ayes-**Elsberg, Hebbeln, and Sowards**. 0-Nays Motion carried.

Approval of the Agenda – **Elsberg** moved, and **Hebbeln** seconded, to approve the **June 5, 2026 “Special”** South Rock Island Township agenda. Roll call vote. 4-Ayes-**Shirk, Elsberg, Hebbeln, and Sowards**. 0-Nays Motion carried.

Approval of Motion and Resolution to Transfer \$20,000 from the Money Market Fund to the Town Fund; Transfer from Town Fund to General Assistance Fund – After discussion, **Elsberg** moved and **Hebbeln** seconded a motion to transfer \$20,000 from the Public Fund High Yield Money Market Fund to the Town Fund. The motion also amended the resolution to authorize Supervisor Grace Shirk to transfer funds from the Public Fund High Yield Money Market to the Town Fund, including the Assessor's Fund and the Relief Fund, as needed to cover expenses. Roll call vote: **4 ayes (Sowards, Shirk, Hebbeln, and Elsberg), 0 nays**. Motion carried.
